All credit card orders must be accompanied by a Credit Card Processing Form found on www.pafbla.org in the Credit Card Payments menu on the left side of the front page. (A non-refundable 3% convenience fee will be added to all credit card orders. The convenience fee will automatically be calculated into the total amount due on the processing form.) The credit card transaction must then be processed through PayPal. Follow the directions on the processing form to complete the credit card transaction.

INCLEMENT WEATHER POLICY FOR THE 2010 PA FBLA STATE LEADERSHIP CONFERENCE:

❶ A full refund (less the 3% convenience fee for credit card sales) will be issued **ONLY IF** the decision **NOT** to go into the Park is made at the time tickets are picked up at the FBLA Tour Desk/Will Call at the *Hershey Lodge*. To receive a refund, the adviser must return the **unused tickets** and complete and sign a Refund Request Form. All refunds will be mailed AFTER the conference. **No REFUNDS** will be issued if you pick up your group's tickets at the FBLA Tour Desk/Will Call at the *Hershey Lodge* and then **enter** *Hersheypark*. Once you enter the Park, you waive your right to a refund.

❷ *Hersheypark* is a Rain or Shine Park. Weather permitting, rides, may be subject to late openings and/or early closures. In the event of severe weather the issuance of a Return Visit Voucher (RVV) will be at the discretion of *Hersheypark* Management. Should the decision be made to issue an RVV ticket, you must stop at the Guest Services window, located outside of the main entrance, with your ticket stub(s) and be leaving the Park for the remainder of the day to receive the RVV ticket. Once you leave the Park, your case is closed. PA FBLA, *Hershey Entertainment*, nor *Hersheypark* are liable for RVV's once you leave the Park.
