Below are the guidelines for this internship:

1. This internship is open to all FBLA members who are interested in or planning a career in the Hospitality Industry. Applicants cannot be competitors at the SLC due to the intensity of this 3-day program.
2. The intern, in consultation with the chapter adviser, is responsible for making and paying his/her SLC Registration Fee, lodging accommodations and travel arrangements. The SLC Package Plan B lodging rates will apply. Complimentary meals will be provided all days of the internship.
3. The internship begins on **Sunday, April 2, (at 9 a.m. and ends on Wednesday, April 5, 11 a.m., subject to change)**. A schedule will be provided by Mr. McCabe, Assistant Director of Convention Services at Hershey Lodge.
4. The intern is expected to follow the 3-day schedule provided by Hershey Lodge—no exceptions.
5. There is no monetary compensation for this internship; however, there are many rewards from this experience. Upon completion of the internship on April 5, if the intern successfully completes all the requirements of the internship as outlined by Mr. McCabe, the intern's adviser may apply for a refund for the intern's 2017 SLC Registration Fee.
