No later than April 30, 2018, competitors in these events must complete and submit the required Event Entry Form to the state office.

This is absolutely critical information that I must have to enter your competitor into the NLC Competitive Events System!

Event entry forms are very slow coming in. That tells me one of two things: (1) students are not planning to attend, or (2) advisers and students need a reminder that this form is required in order to complete.

These events consist of two parts: (1). An objective test, and (2) an interactive role play/performance.

Competitors in each of these events take a collaborative objective test at the NLC.

The top 15 scoring teams advance to the role play/performance. A team is not guaranteed a role/play performance unless it is one of the top 15 scoring teams.

The team must be on top of its knowledge game while taking the objective test. It is important to research and study to make it to the final round.

Pay close attention to the objective test competencies listed for this event. That will give you clear direction regarding preparation for the objective test.
