Subject: SLC Alert #29 – Disney on Ice – Ticket Order Form

Dear FBLA Advisers

Disney on Ice—100 Years of Magic will be at the Giant Center in Hershey on **Sunday, April 7, 2019**, the day before the SLC opens. **Tickets are now on sale through Saturday, March 16, 2019. Payment is due Friday, March 22, 2019.** Tickets must be paid for before they will be distributed.

Advisers are welcome to bring their families to the show. Please read the details below and the information on the order form.

Tickets sold by FBLA are exclusively for FBLA advisers, members and their guests for the Sunday, April 7, performances. Once purchased, tickets are non-refundable and non-transferable. Tickets cannot be used on any other day.

There are two (2) shows on Sunday, April 7:

Show #1: 12 noon – Level 100 seating. Ticket cost @ Group Rate - **\$23 per person**

Show #2: 4 p.m. – Level 100 seating. Ticket cost @ Group Rate: **\$22 per person**

..... Tickets are one price for all (ages 2 and up)

..... Price includes R/T shuttle service from Hershey Lodge to Giant Center

FAQ's about Disney on Ice tickets:

Q Why purchase your tickets from PA FBLA vs. at the Giant Center or from a ticket outlet?

Ans. The FBLA group rate is \$22-\$23 per ticket depending on the performance.

Individual tickets sold at the gate are more—price varies by seat location and availability.

Q Will shuttle buses provide transportation to and from the Giant Center on Sunday, April 7?

Ans. Yes, shuttle buses will transport those going to the Giant Center starting 1 ½ hours before the performance. While the show is in progress, the buses **will NOT** be available. At the end of the show, the buses will be parked in the bus lots. The buses will run 1 hour after the show ends. Please be prompt in catching the shuttle back to Hershey Lodge.

Shuttle buses originate from Hershey Lodge for Hershey Lodge guests and all overflow hotel guests.

Q If we arrive early in Hershey, where can luggage be stored?

Ans. As a courtesy to all conference participants, Hershey Lodge will store luggage in a

secure location while attending Disney on Ice. Upon arrival to Hershey Lodge, take luggage to the Chocolate Ballroom. A bellman will be on duty to tag your luggage.

Q Are family members or FBLA members not attending the SLC welcome to purchase ticket to Disney on Ice for the April 7 performances?

Ans. Yes, tickets may be purchased using the link above. All family members and FBLA members not attending the SLC are subject to the same policies as SLC attendees.

Q Is parking available at the Giant Center?

Ans. Yes, parking at the Giant Center is \$15 per vehicle. The Giant Center has a limited number of parking placards available for PA FBLA. If you are planning to take your own vehicle, please check the box on the ticket order form. Placards are complimentary and available on a first-come basis.
